On behalf of the School Facilities Board, I am pleased to transmit to you the School Facilities Board Annual Report for fiscal year 2017. The report details the Board's actions during the course of the year.

The Board distributed \$26.9 million in Building Renewal Grant funding, \$262,659 in Emergency Deficiencies Correction funding and \$15.4 million in New School Facilities funding. The Overview section of this report presents these and other fiscal year 2017 achievements.

In the coming year, the School Facilities Board looks forward to continuing to improve and maintain school facilities in all school districts within the State. "Partner and advocate, not adversary" is the agency mission as we endeavor to provide guidance and assistance in ensuring measurable preventative maintenance, the design of engaging learning environments, deliberate exposure to best practices, deployment of technologies, and a renewed stewardship in a sustained approach to capital and natural resource consumption.

With these and other measures, the SFB will ensure the academic space, whether funded by the agency or through local funds, will provide engaging learning environments where Arizona's children thrive.

Students FIRST Summary

STUDENTS FIRST In 1994, Arizona's system of school capital finance was declared unconstitutional because it failed to conform to the State constitution's "general and uniform" clause. That system relied on the secondary property tax, driven by the property wealth of a school district, and general obligation bonding. In 1996, the Arizona Superior Court imposed on the State a deadline to develop a constitutional system of school capital finance or risk closure of K-12 public schools. As a result, Governor Jane Dee Hull signed legislation that dramatically reformed the way K-12 schools are constructed in Arizona. This ended the four-year legal and legislative battle and established Arizona as the nation's school finance reform leader. This legislation/law is known as Students FIRST (Fair and Immediate Resources for Students Today).

SCHOOL FACILITIES BOARD Students FIRST is a capital finance program funded by appropriations from the State General Fund. The program is administered by the School Facilities Board (SFB), which consists of nine voting members appointed by the Governor; in addition, the Superintendent of Public Instruction serves as a non-voting member. The Board is charged with the administration of three capital funds: 1) New School Facilities, 2) Building Renewal Grants, and 3) Emergency Deficiencies Corrections.


NEW SCHOOL FACILITIES Students FIRST established a new school facilities fund for the purpose of constructing new schools to meet the minimum adequacy guidelines. The criteria to determine school district eligibility for new school facilities funding are based on an annual evaluation and approval of school district enrollment projections and the additional square footage that will be needed to maintain adequacy standards in a school district.

BUILDING RENEWAL GRANTS The building renewal grant fund was established for the purpose of maintaining the adequacy of existing school facilities. School districts may apply for these monies to fund primary building renewal projects including major renovations and repairs of a building, upgrades to building systems that will maintain or extend the useful life of a building, and for infrastructure costs.

EMERGENCY DEFICIENCIES CORRECTIONS The Emergency

Deficiencies Corrections Program is an application-based funding program wherein school districts may apply to the SFB for funds to correct facility deficiencies that threaten the functioning of the

school district, the preservation or protection of property or public health, welfare or safety. The cost of the correction must also exceed the current year budget.



Introduction

ANNUAL REPORT REQUIREMENTS

The Annual Report requirements are prescribed in A.R.S. §15-2002. The school facilities board shall:

- 9. Submit an annual report by December 15 to the speaker of the house of representatives, the president of the senate, the superintendent of public instruction, the secretary of state and the governor that includes the following information:
- (a) A detailed description of the amount of monies distributed by the school facilities board in the previous fiscal year.
- (b) A list of each capital project that received monies from the school facilities board during the previous fiscal year, a brief description of each project that was funded and a summary of the board's reasons for the distribution of monies for the project.
- (c) A summary of the findings and conclusions of the building maintenance inspections conducted pursuant to this article during the previous fiscal year.
- (d) A summary of the findings of common design elements and characteristics of the highest performing schools and the lowest performing schools based on academic productivity** including the results of the parent quality rating survey.
- ** For the purposes of this paragraph, "academic productivity" means academic year advancement per calendar year as measured with student-level data using the statewide nationally standardized norm- referenced achievement test.



Overview

This report details the School Facilities Board's efforts in its legislatively assigned duties in serving 217 school districts throughout the State of Arizona.

NEW SCHOOL FACILITIES

The School Facilities Board awards New School Facilities funding to school districts that do not have sufficient academic space to educate their students. Sufficient space is determined by comparing school district capacity to ADM (average daily membership).

ADM change is a function of many factors. In order to make the most accurate projections, the SFB closely monitors changes in the broader social, economic, and housing environment, and collects data from a wide variety of sources including:

- Historical ADM data for each school district;
- Historical enrollment data with ethnic and gender makeup information for each school district:
- Demographic, social, and economic profiles on each school district from the U.S. Census and American Community Surveys;

A school district is considered "rural" if it is


than fifty thousand persons. For more detail, see SFB Policy III. Capital Plans, section H.

- Residential housing completion data from Maricopa and Pinal Counties;
- Permitting data from the U.S. Census;
- Housing sales data from online real estate reports and database sites;
- Birth data for all of Arizona:
- Charter school enrollment data;
- Population, housing, and employment projections.

The SFB has built projection models that take advantage of available data and accommodate school districts at different stages of development. In many cases, since these data are not provided at the school district level, the SFB uses GIS software to conduct analyses on a school district level.

In addition, the SFB has calculated and published ADM yield factors (district ADM per residential housing unit) for every school district in Arizona based on the 2000 and 2010 censuses. For each school district in Maricopa and Pinal Counties, ADM yield factors for years between FY 2001 and FY 2017 have been published as well. Collectively, they show how the yield factor for a school district may change over time.

FY 2017 NEW CONSTRUCTION

During FY 2017, the SFB awarded additional space to three school districts. These awards are summarized in the table below:

In addition, Queen Creek Unified was awarded \$17,640,000 for site acquisition. Sites have not yet been selected for the two new schools in Vail Unified, but the Legislature appropriated \$6 million for the high school site and \$1,500,000 for the elementary school site, as placeholders.

Each year, the School Facilities Board reviews the market impact as well as other influencers on construction costs and their effect on projecting accurate and appropriate expenses into the future for the construction of new schools, and makes a recommendation to the Joint Legislative Budget Committee. Recognizing increases is critical to the successful deployment of new and expanded schools that provide engaging and enlightened learning environments consistently to all areas of the State of Arizona.

Teaching and learning for the 21st century prepares young people to engage in a complex and dynamic world deeply influenced by globalization and the revolution in digital technology. Higher student performance is evident in new technology-rich, flexible learning spaces, characterized by open space and permeable boundaries, as well as comfortable and moveable furnishings that encourage flexibility in learning and teaching. This enhances collaborative, team teaching engagement that claims significant educational benefits. This environment of technology-enriched teaching and common spaces, facilitated by multiple teachers/facilitators is far-reaching in the processes, outcomes, assessments, and indicators of student learning.

Construction costs are expressed in dollars per square foot (\$/SF). In FY 17, the \$/SF were increased by 4.31% and these updated amounts are presented on our website and effective December 14, 2016. Shown below is the breakdown by grade configuration.






BUILDING RENEWAL GRANT PROGRAM

In FY 2017, the Legislature appropriated \$31,667,900 to the Building Renewal Grant fund for the School Facilities Board to administer and distribute to school districts for the purpose of maintaining the adequacy of existing school facilities.

School districts may request Building Renewal Grant funding for primary building renewal projects which the Board will prioritize based on school district routine preventative maintenance and the matching of monies provided by the fund. In FY 2017, the SFB approved 539 Building Renewal Grant projects. The Board also approved increases to budgets for 79 previously-approved projects and cancelled 1 previously-approved project. A breakdown of these projects is shown in the charts below.



ADJACENT WAYS

The School Facilities Board is tasked with the review and validation of the compliance with and appropriate use of the Adjacent Ways funding.

Arizona School Districts that have expenditures that are for improvements outside the property lines of the school site but required to serve the school facilities can be funded with Adjacent Ways, which provides the Districts to request the County, having jurisdiction to levy a tax on property owners, to pay the costs of these expenditures.

This funding is for items such as providing utility access to the property line, roads, streets, and sidewalks to the property line so the school is afforded connection to this infrastructure.

The Statute allows for limited use for on-site expenditures and is limited to ingress and egress for emergency vehicles and equipment, as well as school buses within the school property line.

The Statute below defines the appropriate uses for the Adjacent Ways funding.

A.R.S. § 15-995. Special district assessment for adjacent ways by school district

A. The governing board of a school district may contract for constructing, maintaining or otherwise improving any public way adjacent to any parcel of land owned by the school district or leased for school purposes by the school district, or an intersection of any public way adjoining a quarter block in which the parcel of land is situated, and for the construction of sidewalks, sewers, utility lines, roadways and other related improvements in or along such streets and intersections, and to pay for such improvements by the levy of a special assessment on the taxable property in the school district. A school district shall not use any portion of the monies generated from the special assessment for any construction, maintenance or other improvements to the school district's property except improvements necessary to ensure the safe ingress to and egress from public school property directly adjacent to the public way for buses and fire equipment. The assessment shall be made a part of the itemized statement that is regularly filed with the county school superintendent and that shows the amount of monies needed for the expenses of schools within the school district for the ensuing year. Each adjacent ways project proposal to be funded through this special assessment must be filed with the school facilities board and include the project cost estimate. If the entire project cost for the adjacent ways project is greater than fifty thousand dollars, the school facilities board shall approve or deny the project within sixty days after receipt of the filing of the project proposal by the school district and the expenditure shall not be made unless the school facilities board validates both of the following within sixty days after receipt of the filing of the proposal:

- 1. The project that is proposed to be funded by the assessment is compliant with state laws relating to adjacent ways projects.
- 2. The proposal selected by the school district does not contain additional work that is not listed in the adjacent ways proposal submitted by the school district.

B. If any property that is owned by a school district or leased by a school district for school purposes from any city or county, the state, or the United States, is included within the assessment district to be assessed to pay the costs and expenses of any public improvements initiated by a city, in order to make the assessments thereon payable by the city in which the improvement is initiated, the governing board may contract with the municipality or its improvement district to reimburse it for the amount of the assessment against the property and to pay the amount so contracted for by the levy of a special assessment as provided by subsection A of this section.

- C. The governing board of the school district shall follow the truth in taxation notice and hearing requirements prescribed in section 15-905.01, subsection B.
- D. The portion of the primary tax rate to fund adjacent ways as provided in this section shall not be included in the computation of additional state aid for education as prescribed in section 15-972.


EMERGENCY DEFICIENCIES CORRECTIONS

2017 SFB ACCOMPLISHMENTS:

Benson Unified had been awarded funding for a K4 configuration in FY 15. The SFB awarded funding
but there wasn't a plan to build the school, the agency reached out to inquire, why? We were told
by the architect that the SFB formula funding did not provide enough to build the school. Bonding
capacity for the community of Benson provides no additional financial assistance. SFB staff invited
the architect and Benson's superintendent to join us for a meeting at the SFB offices.

Our discussion encouraged the architect and district to open their perspective and imagine something a little different. We're thrilled to report that Benson Unified is in design for a new K4 school building, one which both the architect and district are excited to have underway.

In September of 2016, staff performed a database search to identify how many districts throughout
the State have been provided Building Renewal Grant funding to address facilities that have fallen
below Minimum Adequacy Guidelines. We found that roughly 100 out of the 217 districts that are
eligible for these funds had never made application.

Through the agency's efforts to provide information to all districts about the program in an effort to sustain capital assets, there are currently 173 districts out of the 217 that have been awarded funds to sustain their facilities.

- The SFB has worked in partnership with ADEQ and ADHS to test and remediate through corrective actions lead in drinking water in districts throughout the State. The SFB is in the final stages of corrective actions and are now underway in closeout activities with the districts providing them all the information about their test results, how often the districts should test drinking water locations as a part of their preventative maintenance, and typical corrective actions required to maintain compliance with EPA guidelines.
- Safford Unified was hit by a hail storm and rain in late 2016 that caused significant flooding and damage to four schools within the district. These schools were devastated. SFB staff responded immediately, coordinat-



ed with the Arizona Risk Retention Trust to identify appropriate insurance funding supplemented by eligible Building Renewal Grant funding to remediate and correct the work. This partnership with the Trust is on-going and has produced great success. The SFB staff also met with and encouraged the City and County to come together and review the overall flood drainage strategies since much of the water accumulation on the school sites came from other parts of the community. This study is currently underway and is being coordinated with the re-grading designs at the four Safford Unified schools.


- Understanding the prompt payment of invoices is paramount to the success of any undertaking and lead the
 agency to identify an AMS Breakthrough for Days it takes to process a payment. Since all transactions for
 funding applications are on-line, SFB staff has been working to complete the 'PayAppinator' that will allow all
 payment applications, change orders and other financial transactions to be initiated and completed on-line.
 This application is developed in-house and is currently in Beta test running parallel to the process now in
 place. Final release is scheduled for January 2018.
- Many other initiatives are underway and even more successes are being realized as we right-size our agency
 personnel to align with the growing workload. Additionally, adherence to roles for some of our critical staff
 positions such as a staff architect who was filling in for Liaison activities, allows the agency to impact the
 creation of engaging learning environments through design review and participation on selection committees
 for the design and construction awards.

RUBBER FLOORING PROGRAM

During FY 17 the SFB continued to make payments for projects that had been identified during FY 16 as part of the Rubber Flooring program. This program is described in detail in the Agency's FY 16 Annual Report.

The walls were wrapped in paper capturing ideas, ideals, and flowcharts mapping our path toward a culture that focuses on identifying our value proposition to School Districts, including funding opportunities, technical support, best practices guidance, and tools that create engaging learning environments where the kids in Arizona thrive.

At the end of our day together, we had a vision that established our position as partner and advocate, never adversary with the School Districts.

The SFB subsequently engaged a consultant to create a new LOGO that would express the vision, mission, and culture of the agency. It represents all of us working together - the District, the Agency, vendors, designers, contractors - all holding each other up as well as the facilities. The entrance door is obvious and welcoming. We are partner and advocate, with the value proposition that informs the Districts so they successfully provide the resources to ensure supportive and engaging learning environments.





ARIZONA MANAGEMENT SYSTEM

"Arizona Governor Doug Ducey says he wants state agencies to make everything they do more efficient and that his office will issue scorecards next year to measure their efforts."

Reported in the Phoenix New Times on December 15, 2015.

The State of Arizona is focused on serving its citizens and has been on a journey to move government at the speed of business. Each of the State Agencies has been challenged to improve their delivery of services offering greater value both in service deployment and capital conservation.

The Governor's Office has implemented a deliberate vision with missions and goals and provided training by industry leaders consulting with agency directors and staff. The School Facilities Board is participating and has identified projects for process improvement, all of which benefit the School Districts, the SFB staff, and the citizens of Arizona.

Our specific process improvement targets are:

- Shorten the process time from receipt of a payment application to disbursement of funds to the districts.
- Increase the number of schools inspected to ensure compliance with Minimum Adequacy Guidelines.
- Increase the number of school districts inspected to ensure compliance with Preventative Maintenance Plans.

The improvement for processing payment applications is a "Breakthrough" project. The SFB is in the process of developing a web-based system to increase the number of complete and accurate payment applications from school districts to streamline the documentation submission, processing, and disbursement of funds for Building Renewal Grant, Emergency Deficiencies Correction, and New School Facilities funding requests. The system will encapsulate and standardize documentation, Board approvals, payment applications, disbursement of funds, and change order requests. The new system will also provide stakeholders immediate access to information regarding amounts requested and paid, work-in-place, and time to process payment applications. This system, coined "The PayAppinator", is scheduled to go live in January 2018. More information is available at https://ams.az.gov/results.


